

Based on the instructions given by **PETRONILO DÍAZ PONCE MEDRANO, Esq.**, Public Prosecutor of the State of Nayarit, I would like to request your valuable collaboration in order to carry out the necessary actions to locate and apprehend **ABBEY LAUREN WILSON**, who has an **ARREST WARRANT** issued against her on March 17 (seventeenth), 2022 (two-thousand twenty-two), by the Magistrate Judge of the First Instance Court of Adversarial Justice, with jurisdiction in the city of Bucerias, Bahia de Banderas, Nayarit, for their probable participation in events that meet the criteria for what the Law considers a **BREACH OF TRUST** crime, against the legal entity called **BIRCHFIELD S. DE R.L. DE C.V**<sup>1</sup>.

An authenticated photocopy of this court order is being sent to you. In addition to the foregoing, I hereby inform you that it is known that the offender can be located in the State of Jalisco.

The request that I hereby make is based on the provisions of Articles 21 and 119 of the Political Constitution of the United Mexican States, clause Twelfth, sections I and II of the collaboration agreement published in the Official Gazette of the Federation on November 23, 2012, signed in the city of Acapulco, Guerrero by the Public Prosecutor's Office of the Republic, the State Attorney General's Office and the Attorney General's Offices and Prosecutor General's Offices of the different States, likewise, it was subscribed in the city of Acapulco, Guerrero on November 24, 2011, at the XXVI Plenary Session of the National Conference on the Enforcement of Justice, as well as Articles 94, Section VI, of the Political Constitution of the Free and Sovereign State of Nayarit and Article 12 of the Organic Law of the Attorney General's Office of the State of Nayarit.

I hereby inform you that on this date, resulting from the criminal case number 180/2022 opened against ABBEY LAUREN WILSON for a crime of Breach of Trust to the detriment of BIRCHFIELD S. DE R.L. DE C.V., a resolution was issued, which literally states as follows:

#### In Bucerias, Bahia de Banderas, Nayarit; March 17 (seventeenth), 2022 (two thousand twenty-two).

Whereas. To decide whether or not the arrest warrant requested by Mr. Luis Alonso Frisbi Becerra, Agent of the Public Prosecutor's Office assigned to this Court, against ABBEY LAUREN WILSON, for the crime of Breach of Trust committed against the moral integrity of BIRCHFIELD S. DE R.L. DE C.V., resulting from the criminal case number 180/2022, shall be enforced.

**First**. This First Instance Court of Adversarial Justice has the authority to hear and decide on the petition filed by the Public Prosecutor's Office, since the events referred to in the case at hand were committed where this Legal Body has jurisdiction. Article 20, Section I of the National Code of Criminal Procedure and 41 bis of the Judiciary Act of the State, as well as in terms of the Implementation of the Adversarial Justice System in the State of Nayarit, as well as the extension of the aforementioned declaration.

**Second**. A written request was received at the clerk's office, filed by Mr. Luis Alonso Frisbi Becerra, a Public Prosecutor's Agent assigned to this Court, requesting an arrest warrant against ABBEY LAUREN WILSON, for a crime of Breach of Trust committed to the detriment of BIRCHFIELD S. DE R.L. DE C.V., who has also provided the rational grounds and invoked the evidence in support of his petition. Articles 141, 142 and 143 of the National Code of Criminal Procedure.

Second. The need for caution is also justified in accordance with Article 168, sections I, II, and III of the National Code of Criminal Procedure, and therefore, an **arrest warrant** is issued against **ABBEY LAUREN WILSON**, for their probable participation as a direct perpetrator in the commission of an action that has the elements of the crime of Breach of Trust to the detriment of the legal entity called **BIRCHFIELD S. DE R.L. DE C.V**.

**Third**. Let this resolution be forwarded to the Agent of the Public Prosecutor's Office so that he may order its execution, and once the offender has been apprehended, place them at the disposal of this Court for the formulation of the corresponding indictment.

Fourth. The proceedings are suspended until the arrest of ABBEY LAUREN WILSON.
